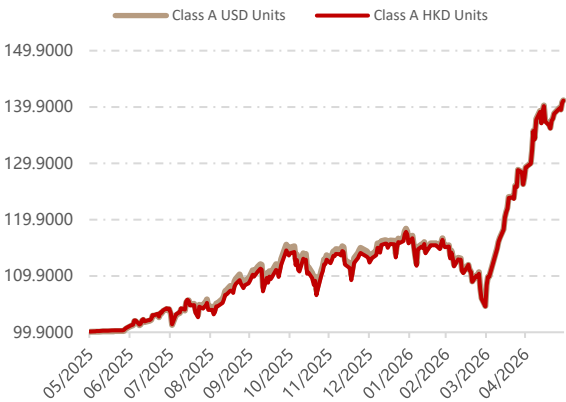

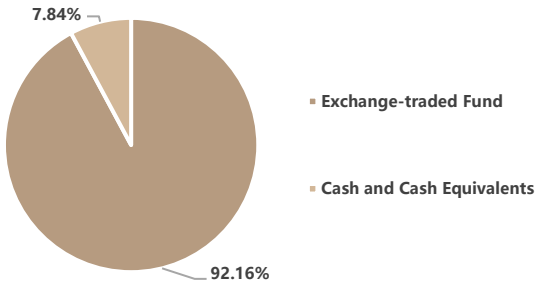

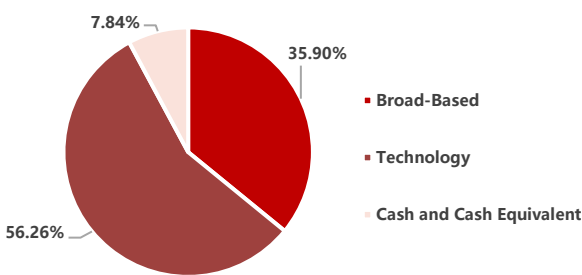

Asset Allocation

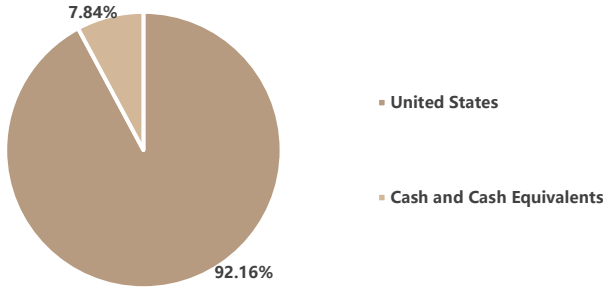


Industry Allocation
